Vestry Meeting Minutes

Call to Order: 7:05 PM

Opening Prayer: Deb O'Donnell

1. Approval of Vestry Meeting Minutes for November 30, 2022, submitted by Rich Connell. Motion to accept the minutes with corrections: Bob Dugger, second Ralph Urban. The minutes were unanimously approved by the vestry.

2. Nursery Room Attendant was interviewed by Deb O'Donnell and Joyce Reynolds on December 14, 2022.

A motion was presented by Deb O'Donnell that we offer the current candidate the position of Nursery Room Attendant pending a background check, references, and the completion of Safe Church Training. \$2500 to be added to the current budget to support this position. Becky Lee second. The motion was unanimously approved by the Vestry.

- 3. (3) Copy machine Lease agreements were previously reviewed by Mitch Chester (Taskaifa, Cannon and Ubeo). The recommendation is that St James enter a contract for a copier, with a lease agreement and service contract with Canon. A motion was presented by Ralph to accept the recommendation and to add \$2800 to the budget to support both the lease and service contract. Rich Connell second. The vestry voted unanimously to accept the motion as proposed.
- 4. A motion was presented by Ralph Urban to purchase "Constant Contact" a soft ware program that will enhance our website, and permit an easier more professional look to newsletters, etc. The contracted cost is \$45.00 per month. The motion was seconded by Bob Dugger. The Vestry accepted the motion and voted to approve unanimously.

- 5. Copies of the By-Laws were distributed to members to review and confirm the requirements and terms for Vestry officers and members.
 - Discussion: "Vestry members must be 18-years of age."
 - "The senior warden and the Rector shall jointly chair the Vestry meetings"

After a thorough discussion, and several proposed changes in language throughout the document, it was concluded that each Vestry member should review their copy of the existing By-Laws and propose suggested changes. Changes may be submitted to Deb O'Donnell. Further discussion and a vote approving any proposed changes in By-Laws will be deferred to the next Vestry Meeting in January.

Becky Lee and Rich Connell are leaving the Vestry in January 2023 after each completing a three-year term. A nomination Committee has been formed to nominate their replacements on Vestry, and for one additional member to serve on Vestry. Membership for this committee: Becky Lee, Rich Connell, and Deb O'Donnell.

As defined in the By-Laws, a Junior Warden may serve a term of three years. As a result, Mitch Chester has completed a three-year term as the Junior Warden. Don Gardner will be nominated as the next Junior Warden, with Mitch Chester serving Don's remaining term on Vestry.

6. Budget: Bob Dugger

A detailed proposed 2023 budget was presented by Treasurer, Bob Dugger, as proposed by the Finance Committee.

- 2023 decreased to a current 59 pledges (19 are still unaccounted and will be contacted via telephone to explore their commitment to making a pledge for 2023.)
- 2023 Proposed Operating Pledge Income: \$210,000 (2022 \$232,431)
 printed spreadsheets detailing income and expenses for the year were provided for the discussion
- The Vestry recommended adding a \$5000 budget to Faith N Action for the 2023 year
- Allocations from the Joining Jesus Account were reviewed for 2020 and 2021.
 Request has been made for a detailed spending account from Joining Jesus for 2022.
